**Terms and Conditions**

This document outlines what Adan Romo - ROAMN Tours agrees to provide when you sign up for a tour, and what you agree to do in return. This is very important information, so please read it carefully before you complete your reservation request.

**Tour price guarantee:** Your price for the tour you've selected will be locked and guaranteed the moment we receive your deposit.

Included in the price of each tour: Sightseeing tours by Adan Romo, and local guides when appropriate, including admissions to sights seen as a group; all breakfasts, half of your lunches, half of your dinners (as determined by Adan Romo); accommodations each night, often in family-run hotels in the historic heart of each city; all transportation from your arrival to your departure (does not include optional activities or independent travel during the tour); all guide, local guide and driver tips.

**Itineraries are subject to change:** Europe is full of surprises and we need to be flexible enough to take advantage of whatever comes along so that we may provide you with the best possible tour. Uncompleted portions of the tour itinerary are not cause for refund.

**Tour payments:** To reserve a seat on an Adan Romo tour you must agree to these Tour Conditions and provide us with a deposit of \$500. We accept cash or a personal check written on a US bank account (or a bank draft/money order drawn on a US or Canadian bank) made payable to "Adan Romo" in US dollars. Your final tour payment is due in our office at least 60 days prior to the start of the tour, in one payment. Please mark your final payment due date on your calendar. If you sign up for a tour less than 60 days before its departure, the entire tour price must be paid, and the deposit portion is non-refundable. (Tour deposit refunds are discussed below.)

**Solo travelers and single supplements:** If you are traveling solo, you need not pay the mandatory single supplement often required by other tour companies. You will most likely room with another tour member of the same sex. If you wish to guarantee a private room, we offer a limited number of optional single supplements for an additional fee. If a private room is not available when we receive your tour order, we will notify you immediately, and you will have the option to cancel your reservation. Please note that a single supplement guarantees a private room - not a larger or nicer room, as European single-bed rooms are generally the smallest and most basic rooms the hotel has to offer. Single supplements are refundable if cancelled at least 60 days prior to tour departure; those cancelled later will be forfeited.

If a payment to Adan Romo is returned unpaid for any reason, we will assess a \$35 returned item fee per occurrence. The fee(s) will be added to the applicable tour balance, and must be paid in full prior to your tour departure.

**Cancellations and refunds:** Deposits for tours are 100% refundable for 30 days from the date they are received. After 30 days your deposit becomes non-refundable, and will be forfeited should you decide to cancel your reservation. Refunds for cancellations made prior to 60 days before departure date will be refunded in full. If ROAMN Tours purchased your air travel, your refund for payments made will reflect the price of the tour minus the cost of the flight. The ticket will be yours to use and it will be your responsibility to contact the airlines for all necessary changes. Payments are non-refundable for cancellations made less than 60 days before a tour departs. Tour forms, obligations, and risks: To travel on a tour all tour members are required to sign and return a Release and Waiver Agreement prior to the beginning of a tour. Any pre-existing physical, mental, or emotional disability that may require attention or treatment must be reported prior to the beginning of a tour. Omitting important information, or altering the Release and Waiver Agreement, could result in expulsion from a tour at your own expense.

Participation: Although we want everyone to have a good time, it sometimes happens that someone participating in a tour can misbehave or do things that are incompatible with the safety, comfort or convenience of other members of the tour. In those circumstances we have the exclusive right and discretion, to expel someone (even you) from a tour at any time, without any claims or complaints by you against us.

All Adan Romo - ROAMN tours are physically active: This is an integral, essential part of the tour experience. You should be capable of fully and happily participating "without any assistance" in the following levels of activity:

Carry or roll your own luggage for up to 15 minutes over uneven pavement from the bus to the hotel.

Be comfortable on your feet with brisk two-hour walking tours, climbing lots of stairs, hopping on and off public transportation, plus standing and walking for up to four hours inside museums and outdoors in all weather conditions.

Sleep in European size rooms.

After orientation and transportation lessons, be able to navigate the area around your hotel on your own.

Adan Romo can provide limited assistance for these activities. Tour members requiring help \ must be accompanied by an able companion who can be entirely responsible for providing the assistance. (If you have concerns about the physical demands of my tours, please call me!)

You'll want to pack light: It is recommended that each tour member bring just one airline-carry-on-size piece of luggage (approx. 21" x 14" x 9") plus a small day pack or shoulder bag. You will always carry your own bags from the bus to your room, which may include carrying them up several flights of stairs or walking 10-15 minutes to the hotel. Your Pre-Tour Planner includes tips for packing light and creatively.

No grumps: Travel is all about experiencing things we're not used to. Tour members are expected to be flexible and open-minded, and to practice considerate social behavior toward one another.

No smoking is allowed on the bus, in hotel rooms or during group meals. Smokers may smoke only outdoors and downwind from the group.

Children under age 18 must room with and be accompanied on the tour by a parent or guardian, who is responsible for participating in all tour activities in which the child partakes.
